- 5. All bids must be accompanied by a bid security of Rs.45,000.00 in cash or form of a bank guarantee, issued by a commercial bank operating in Sri Lanka approved by the Central Bank of Sri Lanka. Bid security must be valid for 90 days from the bids opening (including opening date).

Duly completed original bids should be delivered with duplicates in separate covers marked as "Original and Duplicate" and enclosed in one envelope marked with the caption "Developing Internal Roads Dartonfield.." on the left side of the envelop should be forwarded to below mentioned address by registered post or should be placed in to a box available at the same address on or before 10.30 am on 08.10.2025.
