- e. Shall not have been black listed.

- 5. All bids must be accompanied by a bid security of Rs.126,000.00 in cash or form of a bank guarantee, issued by a commercial bank operating in Sri Lanka approved by the Central Bank of Sri Lanka. Bid security must be valid for 90 days from the bids opening (including opening date).
